EXTENDED - 11 PAY PLAN

The school will give a 10% discount on tuition **only** for each member from the same family after the first. A \$25 charge will be assessed on all NSF’s.

* Books will not be given to students who withdraw from Lake Castle for any reason, including dismissal from Lake Castle.

****YEARBOOK IS INCLUDED IN THE NON-REFUNDABLE “OTHER FEES.”**

Refund Policy: If a registered student does not attend Lake Castle, 75% of the student’s **total annual tuition owed** will be refunded. If a student withdraws or is dismissed from Lake Castle at any time during the first semester, 50% of the student’s **total annual tuition owed** will be refunded. No refund will be given if a student withdraws or is dismissed during the second semester. The only exception to this refund policy is medical reasons, which shall be discussed with the Head of School and handled on an individual basis. Any withdrawal from Lake Castle must be submitted to the office in writing. **THE REGISTRATION FEE AND THE “OTHER FEES” ARE NON-REFUNDABLE.**

The online portal will open on **January 9, 2023** for you to begin the process.

NOTE: You can either pay the school directly or pay online with Gulf Coast Bank your registration, and/or other fees.

The 11-Month Pay Plan is paid directly to Gulf Coast Bank.

Payment options include:

➤ **Pay by E-Check**

Payment of Registration, and/or Other Fees

Pay the school in full by scheduling your One-Time payment through our website; all you need is your bank routing number and checking/savings account number. No payment fee applies to this option.

➤ **Pay by Loan** *Extended – 11-Month Pay Plan*

Financing option for 11-Month Pay Plan will open online effective April 4, 2023.

Easy application for you to complete. School approval is required.

- ✓ Loan interest rate is 4.00%.
- ✓ One-time fixed \$25.00 Origination Fee per loan / school term.
- ✓ Option to finance an 11-month loan - first payment begins June 1, 2023.
- ✓ **Payment due dates will be on the 1st of every month.**
- ✓ Late fees incur if your payment is late after 10 days (refer to your borrower agreement for details).
- ✓ Final payment due April 1, 2024, however, you can pay your loan in full before the maturity date without penalty.
- ✓ Payments can be made online, at a branch location, by mail, bank draft, or pay by phone via checking account.
- ✓ Loans past due 60 or more days may be referred to an attorney for further collection procedures.
